## Roads

-245<sup>th</sup> has been used and maintained for 6 years. It will need to be added to the township roads map. We have the 17 feet of the road and 12 feet on each side for snow storage, 41 feet total. M/S Lyle Reynolds/Barb Kilpatrick to get a survey for a legal description for a resolution, not to exceed 1000.00. Motion passed unanimously. We will contact Passe Engineering. Further discussion was tabled until the survey is received.

-On 267<sup>th</sup>, a survey marker was taken out and needs to be replaced. Lyle will check and it will be replaced in the spring.

-Some gravel was lost due to plowing before frost, with the early snow storm.
