M/S Lyle Reynolds/Chris Olson to approve the minutes of the January 11, 2016 meeting as presented. Motion passed unanimously.

Review Action Items

Action items were reviewed and discussed. Those remaining were:

-Russ will check to see what portion of the parking lot repair should belong to Connexus.

Approve Agenda

M/S Lyle Reynolds/Barb Kilpatrick to approve the agenda as amended. Motion passed unanimously.

Planning and Zoning

- -One permit this month.
- -Legal notice of the 4/40 will be in the paper 1/20/16.
- -Discussion was held regarding an IUP for Steve Benolkin.

M/S Chris Olson/Lyle Reynolds to approve Resolution 2016-02 after revision striking item 6. Motion passed unanimously.

- -Most cleanups are on hold until spring.
- -Inspections are up to date.
- -Bjorklund's have submitted a permit application for a second addition to Emerald Estates. It will be 60-90 days for soil borings and then the issue will go to P&Z.
- -The vacancy on P&Z was discussed and candidates were presented. Jim will look at terms and the bi-laws and bring them to the March meeting.

- -Carolyn is working on meshing the 2/40 with the 4/40 or possibly dropping 2/40.
- -Lyle gave a county update.

Roads

-Discussion was held about grader repairs.

M/S Chris Olson/Lyle Reynolds to approve up to 14000.00 for grader repairs. Motion passed unanimously.

- -Gravel bids will be posted for the April meeting.
- -A grading contract was discussed and it was decided we don't need one.
- -M/S Jan Palmer/Dave Beckstrom that Bud/Bjorklund's will continue with grading as is for the upcoming season. Motion passed unanimously.
- -Chris will contact an engineer to look at 253rd. Craig had mentioned putting a mat down and raising the road, estimated cost at approximately 14,000-17,000 dollars.

- -Dave gave a Highway 65 update.
- -There was no watershed report this month.

Fire

-Shannon, the woman hired for the fire district, did not accept the position. Clint (from Brainerd) has been hired and will be staying at station 3. Jan Palmer was re-elected as chair of the fire board.

Parks

- -The balance in the park fund is 42,154.63.
- -No meeting was held this month. They will begin again in March.
- -There are grants available from the DNR that could be used to shore up the banks of the river in Anderson park.
- -The signing bonus for the cell towers will be sent to Jan and added to the park fund.
- -We received quotes for permanent bathrooms for the ball fields and also for a practice field open to everyone.

M/S Chris Olson/Lyle Reynolds to proceed with the extra field. Motion passed unanimously.

Clerk's Report

- -Diane posted and published the Board of Audit meeting for February 1, 2016 at 6:30 PM.
- -Spring short course date is March 22 at the Holiday Inn in St. Cloud.
- -All 2015 reports are completed and printed.
- -Board of Appeals tentative date is April 27 at 7 PM. All documents have been sent to the county.
- -Please register at your caucus on March 1 for election judge duties.
- -The date of the annual meeting is March 8, 2016 at 7 PM.
