

Minutes of the Regular Athens Town Board Meeting Held April 4, 2016 at the Town Hall

M/S Lyle Reynolds/Chris Olson to approve the minutes of the March 7, 2016 meeting as presented. Motion passed unanimously.

Review Action Items

Action items were reviewed and discussed. Those remaining were:

- Barb will check to see what portion of the parking lot repair should belong to Connexus.

Approve Agenda

Planning and Zoning

- The preliminary plat for Emerald Estates was voted on unanimously in favor by the planning commission with conditions outlined by Jim.

M/S Lyle Reynolds/Barb Kilpatrick to approve Resolution 2016-03 approving the preliminary plat for Emerald Estates-second edition with the conditions outlined. Motion passed unanimously.

- Gravel was put down at 245th and Larch.
- Chris is waiting to hear back from the engineer regarding 253rd.

- Dave gave a HWY 65 report. Blaine and Braham have joined the coalition. The joint powers are being rewritten. They are also doing a survey of businesses that use Highway 65 for transport, to see what traffic conditions are costing them.
- There was no watershed report this month.
